How to Calculate Charges

- Choose the UPS domestic service for your shipment. Refer to your UPS Zone Chart at <u>ups.com/rates</u> to determine the appropriate zone.
- Determine the shipment's billable weight. Use a scale to determine the weight of the package. Any fraction of a pound in the total should be rounded up to the next whole pound.

If the dimensional weight of a package exceeds its actual weight, the dimensional weight of the package will be used to calculate the billable weight. (See the current "UPS® Rate and Service Guide" for instructions on how to determine dimensional weight.) Obtain the shipment's billable weight by totaling the weights of the individual packages in the shipment.
